Damariscotta Pumpkinfest & Regatta selects artisans based on several criteria including authenticity of workmanship, originality and booth presentation. Presentation is of the utmost importance. Each and every application will be juried – previous participation in Damariscotta Pumpkinfest & Regatta does not guarantee acceptance. Thank you!

### **General Information:**

Set up is EVERY DAY between the hours of 7 am and 9:30 am. The show is open Saturday, Sunday, and Monday from 10 am to 2 pm. Exhibitors must provide their own 10' x 10' tent and be prepared for inclement weather as the festival continues rain or shine.

### **Payment:**

A \$100 booth rental check is due by Saturday, October 6<sup>th</sup> prior to setting up. Application deadline is September 30, 2018. Jury results will be sent by October 1<sup>st</sup>.

### **Booth Spaces:**

Booth spacing is very limited, and in a prime Water St./Main St., Damariscotta location. Tens of thousands of visitors come to the Damariscotta Pumpkinfest & Regatta over the three-day weekend.

### **Parking:**

Parking will be provided as part of the booth fee, and will be within walking distance of your booth.

\*No alcoholic beverages or drugs will be permitted.

\*Exhibitor DOGS are NOT ALLOWED.

\*All exhibitors must be open Saturday, Sunday, and Monday from 10 am to 2 pm. Packing up and leaving early is prohibited.

\*No refund will be given to exhibitors requesting to leave early.

\*The Festival committee reserves the right to remove anyone not complying with the rules.

**TO APPLY:** The jury committee evaluates applications based on materials submitted. Please write a brief description of your craft explaining the process, technique and materials used along with a price-range. A professional booth display is extremely important as well.

\_\_\_1. **Application Form.** Maine TAX ID will be required with application. If at time of application your tax id is *pending*, it must be presented on the 1<sup>st</sup> day of the show. To obtain a Maine state sales tax identification number, also known as a seller's certificate, the forms are available on Maine Revenue Services website: [www.mainesbdc.org/faq.cfm](http://www.mainesbdc.org/faq.cfm) or by calling 207-624-9693.

\_\_\_2. **Photos, samples, or brochures** of ALL crafts to be sold at the festival.

\_\_\_3. **Photo of your Booth display** labeled with your name for us to retain.

\_\_\_4. **Hold Harmless Agreement (signed).**
